TRUSTEES' REPORT
FOR THE YEAR ENDED 31 OCTOBER 2009

The Trustees, who are also directors of the charity for the purposes of the Companies Act, submit their annual report and the audited financial statements of Verification Research, Training and Information Centre (the company) for the ended 31 October 2009. The Trustees confirm that the annual report and financial statements of the company comply with current statutory requirements, the requirements of the company's governing document and the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" issued in March 2005.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing Document

The company is constituted under a Memorandum of Association and is a registered charity number 1073051.

The company is registered as a charitable company limited by guarantee and is governed by its Memorandum and Articles of Association as incorporated on 17 August 1998, and subsequently amended on 2 October 2000.

How the charity is constituted

The company is registered as a charitable company limited by guarantee. A Board of Directors governs the company. The non-executive directors of the charitable company are its trustees for the purpose of charity law. The Board is responsible for overall control of VERTIC's operations and meets regularly to review VERTIC's performance as well as to plan and authorize strategic decisions. The Executive Director is responsible for day-to-day administration.

Methods adopted for the recruitment and appointment of new trustees

In accordance with VERTIC's constitution, the maximum number of Board members is determined by the company in general meeting and the minimum number in office at any given time must be three. At the Annual General Meeting on 25 February 2009 all of the existing Board members resigned and were eligible for reappointment. The Board of Directors has the power to appoint new Board members at any time up to the maximum fixed amount, currently eight persons.

Trustee induction, training and recruitment policy

The trustees fully recognize the importance of ensuring that the governance systems for VERTIC reflect both good practice and Charity Commission guidance, and that they are also workable for VERTIC, given its staff size, resources and range of activities. In this regard, the trustees maintain their interest in improving trustee induction, training and recruitment.

Risk assessment

The trustees, in consultation with VERTIC staff, regularly review the major risks to which the company may be exposed and the efficacy of the systems and procedures established to manage such risks.

OBJECTIVES AND ACTIVITIES

Summary of the charity's objectives

The company is established:

- To conduct research and obtain information on verification, monitoring and implementation of international and intra-national agreements, arrangements and related issues; and
- To publish such information both indirectly through the media channels and directly through its own publications; and
- To conduct training in verification, monitoring and implementation of international and intra-national agreements and related issues.

OBJECTIVES AND ACTIVITIES (continued)

Aims of the charity

VERTIC promotes effective verification of international agreements as a means to ensure confidence in the implementation of these agreements, and also intra-national agreements with international involvement. Its primary research and training activities focus on arms control and disarmament and environmental issues. It also maintains an interest in verification issues related to peace accords, although this programme had no active projects during this financial year.

The objectives of VERTIC's three year strategic plan (2006-8) as set forth in detail in the Trustees' Report for the year ended 31 October 2006 was carried over into 2009. These objectives may be summarised as follows:

- **Research:**
To maintain and enhance VERTIC's reputation for authoritative and impartial research of the highest quality, suggesting practicable solutions as appropriate.
- **Influence and change objectives:**
To help set and inform the agendas for public and wider political discussion related to verification issues through productive interaction with the key verification communities.
- **Public profile, information dissemination and awareness-raising objectives:**
To promote greater awareness and understanding by governments and civil society of the role and importance of verification in effective implementation of international agreements.
- **Capacity building and training objectives:**
 - 1) To enhance VERTIC's ability to develop training materials and packages for state governments on the implementation and verification of international agreements.
 - 2) Where appropriate, to promote and facilitate civil society engagement in monitoring and verification through offering suitable training materials.
- **Organisational funding objective:**
To secure adequate, stable and sustainable funding to ensure VERTIC has the resources to carry out its mission.
- **Management, administration and governance objectives:**
 - 1) to maintain and improve the efficacy of management systems to enable VERTIC to operate in a productive, cost-effective manner, including supportive staff management.
 - 2) Similarly, to ensure effective Board oversight and governance of VERTIC's activities.

Strategies for achieving the stated objectives

VERTIC aims to achieve its mission through research, training, dissemination of information, and interaction with the relevant political, diplomatic, technical, scientific, inter-governmental communities and civil society. It cooperates closely with United Nations (UN) bodies and other inter-governmental organizations. VERTIC has consultative (roster) status with the Economic and Social Council (ECOSOC) and is affiliated to the IAEA as a non-governmental observer.

VERTIC arranges seminars and workshops as part of its research and training mandate, both on its own and in partnership with other organizations. Staff members also participate in numerous events held by others. VERTIC has a website (www.vertic.org) and an active in-house publications programme. VERTIC researchers also contribute to journals and magazines published by other organisations and provide interviews and commentary to print and broadcast media.

The charity's strategic plan was examined at a strategic review held in September 2009. A new strategic plan may be adopted at the 2010 Annual General Meeting of the Board of Directors.

PUBLIC BENEFIT STATEMENT

The Trustees confirm that they have complied with the duty in section 4 of the Charities Act 2006 to give due regard to the public benefit guidance published by the Charity Commission in deciding the work undertaken by the Charity.

The Trustees are satisfied that VERTIC's work is a matter of public benefit.

- Our work on the effective and efficient verification and implementation of international arms control agreements advances the resolution of conflicts as stipulated in paragraph 2.2.(h) of the 2006 Charities Act;
- Our work on promoting measurable, reportable and verifiable commitments on the environment, in particular illegal logging, falls within the advancement of environmental protection as stipulated in paragraph 2.2.(i) of the 2006 Charities Act.

VERTIC has made a significant contribution to the nuclear disarmament debate through its work on the UK-Norway process on nuclear warhead dismantlement verification. The UK-Norway process is a collaborative effort involving the Atomic Weapons Establishment, VERTIC, and several Norwegian research centres. It examines how a nuclear weapon state can dismantle its nuclear weapons in a transparent and accountable manner. Effective verification is often seen as a problem in nuclear arms reductions. Lower arms levels may lower the risk that a nuclear weapon will be used or accidentally detonated. Such lower risks are to the benefit of the public.

VERTIC's National Implementation Measures programme is helping States to adopt legislation to prevent biological weapons use, as well as rules ensuring effective control over dangerous pathogens. By helping all states to adopt a regulatory framework, in compliance with relevant international law, we help reduce the public's risk of being exposed to a biological terrorist attack and associated sickness or death. Robust national implementing measures help States to safeguard public health and safety.

VERTIC's environment programme's work in support of the Reducing Emissions from Deforestation and Degradation scheme aims to reduce the impact of illegal logging. The public benefits from the conservation of forests that help to absorb greenhouse gases. They also benefit from the protection of larger swathes of natural environments. The people who depend on these forests for their livelihood are direct beneficiaries.

REVIEW OF ACTIVITIES IN THE YEAR

At present, VERTIC is organizing its activities into three programmes: arms control and disarmament, environment and peace agreements. The arms control and disarmament programme is the charity's largest, employing four and a half full time staff. The environment programme employs one staff member. The peace agreements programme is suspended. All programmes are supported by one full time administrator.

The arms control and disarmament programme conducts activities in two major areas: nuclear arms control and disarmament and national implementation measures. The latter area occupies three full time staff members. One and a half staff member implements the nuclear arms control and disarmament programme. The programme is supported by two full time interns, and two part time volunteers.

Research

The nuclear arms control and disarmament programme mostly focussed on research throughout the year. Its main activity was research and evaluation support for the so-called UK-Norway Initiative on verified nuclear warhead dismantlement. This included active participation in planning activities for two major simulated on-site inspection exercises held in Norway (in December 2008 and June 2009). It also included the writing and internal distribution of three major reports – one on verification concepts, and two evaluation reports of the on-site inspection exercises. The programme continued to focus on the evolution of nuclear safeguards, more specifically in the context of the proposed Fissile Material Cut-Off Treaty. It also participated in a number of activities in support of its project on the establishment of confidence-building measures on the Indian subcontinent. In the latter half of 2009, the programme started to implement a project on research materials on the 1996 Comprehensive Nuclear Test Ban Treaty. The first products of this project, written by former technical negotiators of the treaty, is scheduled to appear sometime in December 2009.

Influence and change

All programmes have contributed to this objective. As in previous years, VERTIC's involvement in the UK-Norway Initiative has helped to significantly raise the profile on nuclear disarmament issues. During the year, VERTIC staff has briefed the UK Foreign Secretary twice on matters relating to disarmament and non-proliferation. In addition, VERTIC staff has participated in a briefing session for the UK Prime Minister. VERTIC continues to have excellent relations with most relevant branches with the UK Civil Service, in particular the Foreign & Commonwealth Office and the Ministry of Defence. Our staff members often contribute to civil service thinking, both in its capacity as a government contractor, but also in more informal settings.

In addition, VERTIC has two staff members working overseas: in New Zealand and in the Netherlands. This has significantly enhanced our visibility and ability to influence main-land European as well as Pacific policies.

VERTIC's national implementation project continues to give advice to foreign governments on implementation of international treaties governing weapons of mass destruction. During 2009, we have delivered technical assistance or advice to governments in Africa (January), Asia (February and March), the Middle East (March and October), the Pacific (April and June), South-East Asia (April), Central America (September) and South America (November).

In addition, VERTIC has started to host a number of open meetings at its London headquarters. Of note is the visit of the Executive Secretary of the Comprehensive Nuclear Test Ban Treaty Organization in June 2009.

Public profile, information dissemination and awareness raising

In 2009, VERTIC significantly increased its publication activities. A range of reports were produced during the year. In addition, VERTIC re-launched its newsletter, *Trust & Verify*, in June 2009. Two issues have been produced since then, and the third issue of 2009 is scheduled to appear in December.

Awareness raising activities continued in all programmes. VERTIC staff presented the result of its work to a range of conferences and meetings, including the 2008 preparatory committee of the 2010 Non-Proliferation Treaty Review Conference, two sessions of the Conference on Disarmament, and the Meeting of State Parties to the Biological Weapons Convention. In addition, VERTIC staff members were invited to present at several meetings, including venues such as the Joint Research Centre in Ispra, Italy, the Centre for Nonproliferation Studies, Monterey, California, US, and the King Faisal Specialist Hospital and Research Centre, Riyadh, Saudi Arabia.

Capacity building and training

During the year, VERTIC continued to improve on its technical assistance website: www.vertic.org/nim. In addition, the Centre developed a significant number of training packages and implementation guidelines. The centre is continuously adding resources to its website as the national implementation project progresses.

Organisational funding

All restricted funds are balanced, and implementation is progressing on schedule in most projects. However, despite best efforts, the charity could not significantly increase its unrestricted reserves.

Management, administration and governance

VERTIC is being run cost-effectively. However, our ratio of fundraising and administration costs to total expenditure (FACE) presently stands at about 15 per cent. This level is slightly lower than comparable sized organizations, and could be read as VERTIC not making an adequate investment in fundraising to safeguard its future. Fortunately, this is not the case. The organization's grant portfolio is diverse and the salary to product ratio in most grants is adequate to recover fundraising costs. However, VERTIC's unrestricted reserves remain low. Forward projections indicate that the situation might improve somewhat in FY09/10.

VERTIC held its tri-annual strategic review in late 2009. This review recommended a policy of 'sustainable growth' and 'consolidation' in the upcoming three years. Moreover, steps were taken to improve the charity's governance structures – such as for instance giving the VERTIC Board of Directors their own charity e-mail addresses. The Chief Executive Officer engages with the organization's Board of Directors and volunteers through a monthly newsletter, *the Director's Review*.

FINANCIAL REVIEW

The organisation cleared the restricted fund deficit which was brought forward from the 2006-2008 financial year accounts by securing unrestricted funds for certain services performed.

The Executive Director and Administrator continued to work closely with the book-keeper and VERTIC's accountants to ensure that restricted and unrestricted funds are correctly attributed in the financial accounts and, in conjunction with staff, been working to ensure an appropriate mix of restricted and unrestricted funds are raised, including by:

- 1) Developing full cost recovery budgets for project proposals submitted to funders, including overhead costs;
- 2) Seeking further unrestricted grants from a wider range of funding sources (including charitable foundations and governments);
- 3) Securing more consultancy projects for a wider range of customers and, wherever possible, ensuring that payment for such services is unrestricted funding; and
- 4) Reviewing core costs and seeking ways in which such costs can be reduced.

Investment policy and performance

The Memorandum and Articles of Association provides that the company invests moneys not immediately required for its own purposes in or upon such investments, securities or property, as may be thought fit. At the present time, the trustees' policy is to maintain all such monies on deposits earning a market rate of interest.

Reserves policy

VERTIC seeks to maintain a level of unrestricted reserves that would be adequate to meet all current and known future liabilities. In practice, the trustees consider that holding unrestricted reserves equivalent to three months core costs (approximately £14,834 current costs) is sufficient. As at 31 October 2009, free reserves (excluding fixed assets) amount to £14,440. The Trustees are looking to build up free reserves.

VERTIC's income was £469,342 in the year ended 31 October 2009 compared to £388,928 for the year ended 31 October 2008. The total expenditure was £417,699 for the year ended 31 October 2009 compared to £296,582 for the year ended 31 October 2008. The fund balance carried forward at 31 October 2009 was £18,028 on unrestricted general reserves. The restricted reserves balance on ongoing projects was £175,586 at 31 October 2009. The full Statement of Financial Activities is set out on page 9 of these accounts.

VERTIC holds no significant assets apart from fixtures and fittings, office and computer equipment.

Details of the restricted projects are given in notes 13 to the accounts on page 17. The trustees are confident that adequate resources are available to enable completion of these projects.

PLANS FOR THE FUTURE

The environment programme has had mixed fundraising successes in the past year and is still some way of being fully self sustained. However, the programme forms an integral part of the charity's activities. Its preservation therefore remains a top priority for the coming year. It is presently conducting promising work in forestry governance and in work in support of the REDD (Reducing Emissions from Deforestation and Forest Degradation in Developing Countries) scheme. It is presently involved in a biannual project on deforestation indicators together with Chatham House, and possesses unique expertise in measurable, reportable and verifiable carbon emissions reductions for the forestry sector.

In 2010, the charity will aim to consolidate its expertise in this area by focussing on forestry, and expanded forestry governance (such as legislation, law enforcement and land tenure issues). This will further the charity's role as an implementation assistance provider for interested states. In doing so, VERTIC intends to deepen relations with other service providers in the area - the Foundation for International Environmental Law and Development in particular – with a view of submitting joint bids. The fundraising target for 2010 is modest, simple cost recovery, with a view of expanding our work in the area to two full time staff equivalents in 2011.

The national implementation measures project continues to grow into maturity. The goal for 2010 is to consolidate the charities activities in providing support in the implementation of biological weapons related international law. The charity will also aim to carry out more activities in relation to chemical weapons, in close consultation with the Organisation for the Prohibition of Chemical Weapons, as well as certain implementation activities in the nuclear area (most significantly on norms prohibiting the illicit trafficking of nuclear materials), in close consultation with the International Atomic Energy Agency and the UN Office on Drugs and Crime. This project shows good prospects for continuation post 2011. We aim to enhance our capabilities by expanding this project from three full time staff equivalents to four in 2010.

Our work on chemical and biological arms control and disarmament suffers from a funding shortage. Our traditional funders have withdrawn from this area. However, the issue area shows signs of picking up increased attention in 2010, since there is a renewed interest in multilateral verification. For instance, new so-called Track-II processes are increasingly calling on VERTIC participation. Our goals for 2010 are modest. We intend to complete a fundraising strategy in this area, and leverage our standing acquired through the national implementation measures project, to work up a funding stream by the end of the coming year. We aim to maintain a quarter time staff equivalent on this issue area.

Our work on the nuclear arms control and disarmament programme in 2010 will focus on two issue areas: verified nuclear disarmament and supporting the early into force of the 1996 Comprehensive Nuclear Test Ban Treaty by communicating the readiness of its verification regime. We will aim to consolidate the programme by maintaining its present staffing level of one and a half full time staff equivalents, with a view of growing the programme to about two and a half full time staff equivalent by the end of 2010. New partners will be sought with whom to join efforts, especially in Geneva, Switzerland, and in Washington, DC, USA.

All programmes will benefit from an enhanced public outreach programme. We will aim to continue publication of Trust & Verify on schedule throughout the coming year. Also, we are working to establish a successor publication to the Verification Yearbook in 2011. An interested publisher has already been identified. If negotiations are successful, the charity could aim to work up a copy-flow by the end of this year. The goal is to have the journal completely self-sustained. Therefore, this work is carried out by an external consultant.

TRUSTEES' RESPONSIBILITIES

The trustees (who are also directors of The Verification Research, Training and Information Centre (VERTIC) for the purposes of company law) are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company [and the group] and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that period. In preparing these financial statements, the trustees are required to:

- Select suitable accounting policies and then apply them consistently;
- Observe the methods and principles in the Charities SORP;
- Make judgements and estimates that are reasonable and prudent;
- State whether applicable UK Accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time of the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

In so far as we are aware:

- There is no relevant audit information of which the charitable company's auditor is unaware; and
- The trustees have taken all steps that they ought to have taken to make themselves aware of any relevant audit information and to establish that the auditor is aware of that information.

**INDEPENDENT AUDITORS REPORT TO THE MEMBERS OF

We have audited the financial statements of The Verification Research, Training and Information Centre (VERTIC) for the year ended 31 October 2009 which comprise the Statement of Financial Activities, the Balance Sheet, and the related notes. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice) and the requirements of the Financial Reporting Standard for Smaller Entities (effective April 2008).

NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 OCTOBER 2009

1. ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008). The financial statements have been prepared in accordance with the Statement of Recommended Practice (SORP), "Accounting and Reporting by Charities" issued in March 2005 and, applicable accounting standards and the Companies Act 2006.

1.2 Company status

The charity is a company limited by guarantee. The members of the company are the trustees named on page 1. In the event of the company being wound up, each member is liable to contribute a sum not exceeding £1.

1.3 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the company and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors which have been raised by the company for particular purposes. The cost of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

1.4 Incoming resources

All incoming resources are included in the Statement of Financial Activities when the company is legally entitled to the income and the amount can be quantified with reasonable accuracy. Income from donations and grants is included in incoming resources when these are receivable.

Donated services are included at the value to the company where this can be quantified and a third party is bearing the cost. No amounts are included in the financial statements for services donated by volunteers.

1.5 Resources expended

All expenditure is accounted for on an accruals basis and has been included under expense categories that aggregate all costs for allocation to activities. Where costs cannot be directly attributed to particular activities they have been allocated on a basis consistent with the use of the resources.

Direct costs, including directly attributable salaries, are allocated on an actual basis to the key strategic areas of activity. Overheads and other salaries are allocated between the expense headings on the basis of time spent.

Fund raising costs are those incurred in seeking voluntary contributions and do not include the costs of disseminating information in support of the charitable activities.

Support costs are those costs incurred directly in support of expenditure on the objects of the Charity and are allocated on the proportion of direct costs spent on each activity.

Governance costs are those costs incurred in connection with enabling the charity to comply with external regulation, constitutional and statutory requirements and in providing support to the Trustees in the discharge of their statutory duties.

1.6 Tangible fixed assets and depreciation

All assets costing more than £200.00 are capitalised.

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

Furniture and Fittings	-	25%	reducing balance
Office Equipment	-	25%	reducing balance
Computer Equipment	-	25%	reducing balance

1.7 Operating leases

Rentals under operating leases are charged on a straight line basis over the lease term.

Benefits received and receivable as an incentive to sign an operating lease are recognised on a straight line basis over the period until the date the rent is expected to be adjusted to the prevailing market rate.

1.8 Foreign currencies

Monetary assets and liabilities denominated in foreign currencies are translated into sterling at rates of exchange ruling at the balance sheet date.

Transactions in foreign currencies are translated into sterling at the rate ruling on the date of the transaction.

Exchange gains and losses are recognised in the SOFA account.

1.9 Pensions

The company operates a defined contribution pension scheme and the pension charge represents the amounts payable by the company to the fund in respect of the year.

1.10 Value Added Tax

The charity is not registered for VAT. In common with many other registered charities, The Verification Research, Training and Information Centre's expenses are inflated by VAT, which cannot be recovered.

1.11 Tax status

The company is a registered charity and is not subject to corporation tax on its current activities.

- biological (the Biological Weapons Convention)
- chemical (the Chemical Weapons Convention) and
- small arms and light weapons, including landmines.

TRUSTEES' REPORT
FOR THE YEAR ENDED 31 OCTOBER 2009

The Trustees, who are also directors of the charity for the purposes of the Companies Act, submit their annual report and the audited financial statements of Verification Research, Training and Information Centre (the company) for the ended 31 October 2009. The Trustees confirm that the annual report and financial statements of the company comply with current statutory requirements, the requirements of the company's governing document and the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" issued in March 2005.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing Document

The company is constituted under a Memorandum of Association and is a registered charity number 1073051.

The company is registered as a charitable company limited by guarantee and is governed by its Memorandum and Articles of Association as incorporated on 17 August 1998, and subsequently amended on 2 October 2000.

How the charity is constituted

The company is registered as a charitable company limited by guarantee. A Board of Directors governs the company. The non-executive directors of the charitable company are its trustees for the purpose of charity law. The Board is responsible for overall control of VERTIC's operations and meets regularly to review VERTIC's performance as well as to plan and authorize strategic decisions. The Executive Director is responsible for day-to-day administration.

Methods adopted for the recruitment and appointment of new trustees

In accordance with VERTIC's constitution, the maximum number of Board members is determined by the company in general meeting and the minimum number in office at any given time must be three. At the Annual General Meeting on 25 February 2009 all of the existing Board members resigned and were eligible for reappointment. The Board of Directors has the power to appoint new Board members at any time up to the maximum fixed amount, currently eight persons.

Trustee induction, training and recruitment policy

The trustees fully recognize the importance of ensuring that the governance systems for VERTIC reflect both good practice and Charity Commission guidance, and that they are also workable for VERTIC, given its staff size, resources and range of activities. In this regard, the trustees maintain their interest in improving trustee induction, training and recruitment.

Risk assessment

The trustees, in consultation with VERTIC staff, regularly review the major risks to which the company may be exposed and the efficacy of the systems and procedures established to manage such risks.

OBJECTIVES AND ACTIVITIES

Summary of the charity's objectives

The company is established:

- To conduct research and obtain information on verification, monitoring and implementation of international and intra-national agreements, arrangements and related issues; and
- To publish such information both indirectly through the media channels and directly through its own publications; and
- To conduct training in verification, monitoring and implementation of international and intra-national agreements and related issues.

TRUSTEES' REPORT

OBJECTIVES AND ACTIVITIES (continued)

Aims of the charity

VERTIC promotes effective verification of international agreements as a means to ensure confidence in the implementation of these agreements, and also intra-national agreements with international involvement. Its primary research and training activities focus on arms control and disarmament and environmental issues. It also maintains an interest in verification issues related to peace accords, although this programme had no active projects during this financial year.

The objectives of VERTIC's three year strategic plan (2006-8) as set forth in detail in the Trustees' Report for the year ended 31 October 2006 was carried over into 2009. These objectives may be summarised as follows:

- **Research:**
To maintain and enhance VERTIC's reputation for authoritative and impartial research of the highest quality, suggesting practicable solutions as appropriate.
- **Influence and change objectives:**
To help set and inform the agendas for public and wider political discussion related to verification issues through productive interaction with the key verification communities.
- **Public profile, information dissemination and awareness-raising objectives:**
To promote greater awareness and understanding by governments and civil society of the role and importance of verification in effective implementation of international agreements.
- **Capacity building and training objectives:**
 - 1) To enhance VERTIC's ability to develop training materials and packages for state governments on the implementation and verification of international agreements.
 - 2) Where appropriate, to promote and facilitate civil society engagement in monitoring and verification through offering suitable training materials.
- **Organisational funding objective:**
To secure adequate, stable and sustainable funding to ensure VERTIC has the resources to carry out its mission.
- **Management, administration and governance objectives:**
 - 1) to maintain and improve the efficacy of management systems to enable VERTIC to operate in a productive, cost-effective manner, including supportive staff management.
 - 2) Similarly, to ensure effective Board oversight and governance of VERTIC's activities.

Strategies for achieving the stated objectives

VERTIC aims to achieve its mission through research, training, dissemination of information, and interaction with the relevant political, diplomatic, technical, scientific, inter-governmental communities and civil society. It cooperates closely with United Nations (UN) bodies and other inter-governmental organizations. VERTIC has consultative (roster) status with the Economic and Social Council (ECOSOC) and is affiliated to the IAEA as a non-governmental observer.

VERTIC arranges seminars and workshops as part of its research and training mandate, both on its own and in partnership with other organizations. Staff members also participate in numerous events held by others. VERTIC has a website (www.vertic.org) and an active in-house publications programme. VERTIC researchers also contribute to journals and magazines published by other organisations and provide interviews and commentary to print and broadcast media.

The charity's strategic plan was examined at a strategic review held in September 2009. A new strategic plan may be adopted at the 2010 Annual General Meeting of the Board of Directors.

PUBLIC BENEFIT STATEMENT

The Trustees confirm that they have complied with the duty in section 4 of the Charities Act 2006 to give due regard to the public benefit guidance published by the Charity Commission in deciding the work undertaken by the Charity.

The Trustees are satisfied that VERTIC's work is a matter of public benefit.

- Our work on the effective and efficient verification and implementation of international arms control agreements advances the resolution of conflicts as stipulated in paragraph 2.2.(h) of the 2006 Charities Act;
- Our work on promoting measurable, reportable and verifiable commitments on the environment, in particular illegal logging, falls within the advancement of environmental protection as stipulated in paragraph 2.2.(i) of the 2006 Charities Act.

VERTIC has made a significant contribution to the nuclear disarmament debate through its work on the UK-Norway process on nuclear warhead dismantlement verification. The UK-Norway process is a collaborative effort involving the Atomic Weapons Establishment, VERTIC, and several Norwegian research centres. It examines how a nuclear weapon state can dismantle its nuclear weapons in a transparent and accountable manner. Effective verification is often seen as a problem in nuclear arms reductions. Lower arms levels may lower the risk that a nuclear weapon will be used or accidentally detonated. Such lower risks are to the benefit of the public.

VERTIC's National Implementation Measures programme is helping States to adopt legislation to prevent biological weapons use, as well as rules ensuring effective control over dangerous pathogens. By helping all states to adopt a regulatory framework, in compliance with relevant international law, we help reduce the public's risk of being exposed to a biological terrorist attack and associated sickness or death. Robust national implementing measures help States to safeguard public health and safety.

VERTIC's environment programme's work in support of the Reducing Emissions from Deforestation and Degradation scheme aims to reduce the impact of illegal logging. The public benefits from the conservation of forests that help to absorb greenhouse gases. They also benefit from the protection of larger swathes of natural environments. The people who depend on these forests for their livelihood are direct beneficiaries.

REVIEW OF ACTIVITIES IN THE YEAR

At present, VERTIC is organizing its activities into three programmes: arms control and disarmament, environment and peace agreements. The arms control and disarmament programme is the charity's largest, employing four and a half full time staff. The environment programme employs one staff member. The peace agreements programme is suspended. All programmes are supported by one full time administrator.

The arms control and disarmament programme conducts activities in two major areas: nuclear arms control and disarmament and national implementation measures. The latter area occupies three full time staff members. One and a half staff member implements the nuclear arms control and disarmament programme. The programme is supported by two full time interns, and two part time volunteers.

Research

The nuclear arms control and disarmament programme mostly focussed on research throughout the year. Its main activity was research and evaluation support for the so-called UK-Norway Initiative on verified nuclear warhead dismantlement. This included active participation in planning activities for two major simulated on-site inspection exercises held in Norway (in December 2008 and June 2009). It also included the writing and internal distribution of three major reports – one on verification concepts, and two evaluation reports of the on-site inspection exercises. The programme continued to focus on the evolution of nuclear safeguards, more specifically in the context of the proposed Fissile Material Cut-Off Treaty. It also participated in a number of activities in support of its project on the establishment of confidence-building measures on the Indian subcontinent. In the latter half of 2009, the programme started to implement a project on research materials on the 1996 Comprehensive Nuclear Test Ban Treaty. The first products of this project, written by former technical negotiators of the treaty, is scheduled to appear sometime in December 2009.

Influence and change

All programmes have contributed to this objective. As in previous years, VERTIC's involvement in the UK-Norway Initiative has helped to significantly raise the profile on nuclear disarmament issues. During the year, VERTIC staff has briefed the UK Foreign Secretary twice on matters relating to disarmament and non-proliferation. In addition, VERTIC staff has participated in a briefing session for the UK Prime Minister. VERTIC continues to have excellent relations with most relevant branches with the UK Civil Service, in particular the Foreign & Commonwealth Office and the Ministry of Defence. Our staff members often contribute to civil service thinking, both in its capacity as a government contractor, but also in more informal settings.

In addition, VERTIC has two staff members working overseas: in New Zealand and in the Netherlands. This has significantly enhanced our visibility and ability to influence main-land European as well as Pacific policies.

VERTIC's national implementation project continues to give advice to foreign governments on implementation of international treaties governing weapons of mass destruction. During 2009, we have delivered technical assistance or advice to governments in Africa (January), Asia (February and March), the Middle East (March and October), the Pacific (April and June), South-East Asia (April), Central America (September) and South America (November).

In addition, VERTIC has started to host a number of open meetings at its London headquarters. Of note is the visit of the Executive Secretary of the Comprehensive Nuclear Test Ban Treaty Organization in June 2009.

Public profile, information dissemination and awareness raising

In 2009, VERTIC significantly increased its publication activities. A range of reports were produced during the year. In addition, VERTIC re-launched its newsletter, *Trust & Verify*, in June 2009. Two issues have been produced since then, and the third issue of 2009 is scheduled to appear in December.

Awareness raising activities continued in all programmes. VERTIC staff presented the result of its work to a range of conferences and meetings, including the 2008 preparatory committee of the 2010 Non-Proliferation Treaty Review Conference, two sessions of the Conference on Disarmament, and the Meeting of State Parties to the Biological Weapons Convention. In addition, VERTIC staff members were invited to present at several meetings, including venues such as the Joint Research Centre in Ispra, Italy, the Centre for Nonproliferation Studies, Monterey, California, US, and the King Faisal Specialist Hospital and Research Centre, Riyadh, Saudi Arabia.

Capacity building and training

During the year, VERTIC continued to improve on its technical assistance website: www.vertic.org/nim. In addition, the Centre developed a significant number of training packages and implementation guidelines. The centre is continuously adding resources to its website as the national implementation project progresses.

Organisational funding

All restricted funds are balanced, and implementation is progressing on schedule in most projects. However, despite best efforts, the charity could not significantly increase its unrestricted reserves.

Management, administration and governance

VERTIC is being run cost-effectively. However, our ratio of fundraising and administration costs to total expenditure (FACE) presently stands at about 15 per cent. This level is slightly lower than comparable sized organizations, and could be read as VERTIC not making an adequate investment in fundraising to safeguard its future. Fortunately, this is not the case. The organization's grant portfolio is diverse and the salary to product ratio in most grants is adequate to recover fundraising costs. However, VERTIC's unrestricted reserves remain low. Forward projections indicate that the situation might improve somewhat in FY09/10.

VERTIC held its tri-annual strategic review in late 2009. This review recommended a policy of 'sustainable growth' and 'consolidation' in the upcoming three years. Moreover, steps were taken to improve the charity's governance structures – such as for instance giving the VERTIC Board of Directors their own charity e-mail addresses. The Chief Executive Officer engages with the organization's Board of Directors and volunteers through a monthly newsletter, *the Director's Review*.

FINANCIAL REVIEW

The organisation cleared the restricted fund deficit which was brought forward from the 2006-2008 financial year accounts by securing unrestricted funds for certain services performed.

The Executive Director and Administrator continued to work closely with the book-keeper and VERTIC's accountants to ensure that restricted and unrestricted funds are correctly attributed in the financial accounts and, in conjunction with staff, been working to ensure an appropriate mix of restricted and unrestricted funds are raised, including by:

- 1) Developing full cost recovery budgets for project proposals submitted to funders, including overhead costs;
- 2) Seeking further unrestricted grants from a wider range of funding sources (including charitable foundations and governments);
- 3) Securing more consultancy projects for a wider range of customers and, wherever possible, ensuring that payment for such services is unrestricted funding; and
- 4) Reviewing core costs and seeking ways in which such costs can be reduced.

Investment policy and performance

The Memorandum and Articles of Association provides that the company invests moneys not immediately required for its own purposes in or upon such investments, securities or property, as may be thought fit. At the present time, the trustees' policy is to maintain all such monies on deposits earning a market rate of interest.

Reserves policy

VERTIC seeks to maintain a level of unrestricted reserves that would be adequate to meet all current and known future liabilities. In practice, the trustees consider that holding unrestricted reserves equivalent to three months core costs (approximately £14,834 current costs) is sufficient. As at 31 October 2009, free reserves (excluding fixed assets) amount to £14,440. The Trustees are looking to build up free reserves.

VERTIC's income was £469,342 in the year ended 31 October 2009 compared to £388,928 for the year ended 31 October 2008. The total expenditure was £417,699 for the year ended 31 October 2009 compared to £296,582 for the year ended 31 October 2008. The fund balance carried forward at 31 October 2009 was £18,028 on unrestricted general reserves. The restricted reserves balance on ongoing projects was £175,586 at 31 October 2009. The full Statement of Financial Activities is set out on page 9 of these accounts.

VERTIC holds no significant assets apart from fixtures and fittings, office and computer equipment.

Details of the restricted projects are given in notes 13 to the accounts on page 17. The trustees are confident that adequate resources are available to enable completion of these projects.

PLANS FOR THE FUTURE

The environment programme has had mixed fundraising successes in the past year and is still some way of being fully self sustained. However, the programme forms an integral part of the charity's activities. Its preservation therefore remains a top priority for the coming year. It is presently conducting promising work in forestry governance and in work in support of the REDD (Reducing Emissions from Deforestation and Forest Degradation in Developing Countries) scheme. It is presently involved in a biannual project on deforestation indicators together with Chatham House, and possesses unique expertise in measurable, reportable and verifiable carbon emissions reductions for the forestry sector.

In 2010, the charity will aim to consolidate its expertise in this area by focussing on forestry, and expanded forestry governance (such as legislation, law enforcement and land tenure issues). This will further the charity's role as an implementation assistance provider for interested states. In doing so, VERTIC intends to deepen relations with other service providers in the area - the Foundation for International Environmental Law and Development in particular – with a view of submitting joint bids. The fundraising target for 2010 is modest, simple cost recovery, with a view of expanding our work in the area to two full time staff equivalents in 2011.

The national implementation measures project continues to grow into maturity. The goal for 2010 is to consolidate the charities activities in providing support in the implementation of biological weapons related international law. The charity will also aim to carry out more activities in relation to chemical weapons, in close consultation with the Organisation for the Prohibition of Chemical Weapons, as well as certain implementation activities in the nuclear area (most significantly on norms prohibiting the illicit trafficking of nuclear materials), in close consultation with the International Atomic Energy Agency and the UN Office on Drugs and Crime. This project shows good prospects for continuation post 2011. We aim to enhance our capabilities by expanding this project from three full time staff equivalents to four in 2010.

Our work on chemical and biological arms control and disarmament suffers from a funding shortage. Our traditional funders have withdrawn from this area. However, the issue area shows signs of picking up increased attention in 2010, since there is a renewed interest in multilateral verification. For instance, new so-called Track-II processes are increasingly calling on VERTIC participation. Our goals for 2010 are modest. We intend to complete a fundraising strategy in this area, and leverage our standing acquired through the national implementation measures project, to work up a funding stream by the end of the coming year. We aim to maintain a quarter time staff equivalent on this issue area.

Our work on the nuclear arms control and disarmament programme in 2010 will focus on two issue areas: verified nuclear disarmament and supporting the early into force of the 1996 Comprehensive Nuclear Test Ban Treaty by communicating the readiness of its verification regime. We will aim to consolidate the programme by maintaining its present staffing level of one and a half full time staff equivalents, with a view of growing the programme to about two and a half full time staff equivalent by the end of 2010. New partners will be sought with whom to join efforts, especially in Geneva, Switzerland, and in Washington, DC, USA.

All programmes will benefit from an enhanced public outreach programme. We will aim to continue publication of Trust & Verify on schedule throughout the coming year. Also, we are working to establish a successor publication to the Verification Yearbook in 2011. An interested publisher has already been identified. If negotiations are successful, the charity could aim to work up a copy-flow by the end of this year. The goal is to have the journal completely self-sustained. Therefore, this work is carried out by an external consultant.

TRUSTEES' RESPONSIBILITIES

The trustees (who are also directors of The Verification Research, Training and Information Centre (VERTIC) for the purposes of company law) are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company [and the group] and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that period. In preparing these financial statements, the trustees are required to:

- Select suitable accounting policies and then apply them consistently;
- Observe the methods and principles in the Charities SORP;
- Make judgements and estimates that are reasonable and prudent;
- State whether applicable UK Accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;

NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 OCTOBER 2009

1. ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008). The financial statements have been prepared in accordance with the Statement of Recommended Practice (SORP), "Accounting and Reporting by Charities" issued in March 2005 and, applicable accounting standards and the Companies Act 2006.

1.2 Company status

The charity is a company limited by guarantee. The members of the company are the trustees named on page 1. In the event of the company being wound up, each member is liable to contribute a sum not exceeding £1.

1.3 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the company and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors which have been raised by the company for particular purposes. The cost of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

1.4 Incoming resources

All incoming resources are included in the Statement of Financial Activities when the company is legally entitled to the income and the amount can be quantified with reasonable accuracy. Income from donations and grants is included in incoming resources when these are receivable.

Donated services are included at the value to the company where this can be quantified and a third party is bearing the cost. No amounts are included in the financial statements for services donated by volunteers.

1.5 Resources expended

All expenditure is accounted for on an accruals basis and has been included under expense categories that aggregate all costs for allocation to activities. Where costs cannot be directly attributed to particular activities they have been allocated on a basis consistent with the use of the resources.

Direct costs, including directly attributable salaries, are allocated on an actual basis to the key strategic areas of activity. Overheads and other salaries are allocated between the expense headings on the basis of time spent.

Fund raising costs are those incurred in seeking voluntary contributions and do not include the costs of disseminating information in support of the charitable activities.

Support costs are those costs incurred directly in support of expenditure on the objects of the Charity and are allocated on the proportion of direct costs spent on each activity.

Governance costs are those costs incurred in connection with enabling the charity to comply with external regulation, constitutional and statutory requirements and in providing support to the Trustees in the discharge of their statutory duties.

1.6 Tangible fixed assets and depreciation

All assets costing more than £200.00 are capitalised.

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

Furniture and Fittings	-	25%	reducing balance
Office Equipment	-	25%	reducing balance
Computer Equipment	-	25%	reducing balance

1.7 Operating leases

Rentals under operating leases are charged on a straight line basis over the lease term.

Benefits received and receivable as an incentive to sign an operating lease are recognised on a straight line basis over the period until the date the rent is expected to be adjusted to the prevailing market rate.

1.8 Foreign currencies

Monetary assets and liabilities denominated in foreign currencies are translated into sterling at rates of exchange ruling at the balance sheet date.

Transactions in foreign currencies are translated into sterling at the rate ruling on the date of the transaction.

Exchange gains and losses are recognised in the SOFA account.

1.9 Pensions

The company operates a defined contribution pension scheme and the pension charge represents the amounts payable by the company to the fund in respect of the year.

VERTIC promotes effective verification measures for, and monitors the implementation of and compliance with all major arms control and disarmament regimes, including:

- nuclear (notably the Nuclear Non-Proliferation Treaty, including International Atomic Energy Agency nuclear safeguards, the Comprehensive Nuclear Test Ban Treaty)
- biological (the Biological Weapons Convention)
- chemical (the Chemical Weapons Convention) and
- small arms and light weapons, including landmines.
